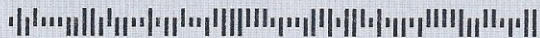

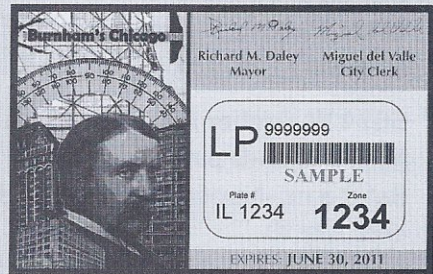

EXPLANATION OF FEES:

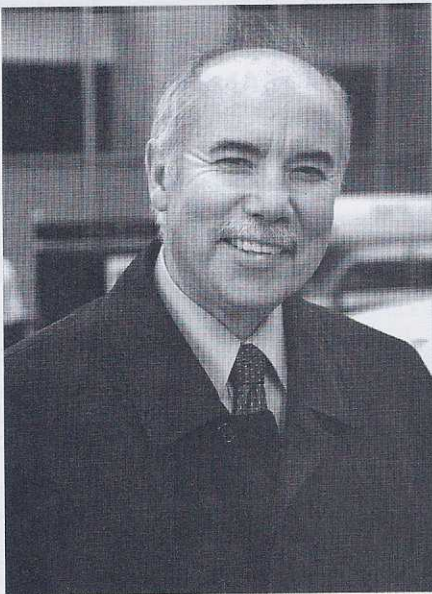
- The revenue generated is used to maintain arterial streets.
- Failure to display a vehicle sticker is subject to a \$120 citation.
- After July 15, 2010, a \$40 late fee will be assessed.

BEWARE OF FRAUDULENT STICKERS:

- Only buy vehicle stickers from an authorized location.
- Purchase and display of a fraudulent sticker could result in a \$500 citation as well as the towing and impoundment of the vehicle.
- If you witness the sale of fraudulent stickers, please call 911. To identify fraudulent stickers, visit www.ChiCityClerk.com.

SENIOR CITIZENS:

- Persons 65 years or older are eligible for only one \$30 discounted vehicle sticker for a passenger or larger passenger vehicle. A copy of a valid Illinois Driver's License is required to receive this discount.
