NOTICE AND INSPECTION REPORT

FLORENCE COUNTY Sanitary Ordinance Section 7.0 and Comm 83 and 84, Wisconsin Administrative Code and Wisconsin statues 145.20 (2) (i) requires that owners of Private Onsite Waste Treatment Systems (POWTS) are required to participate in a Private Sewage System Maintenance and Management Program. All POWTS, shall have the septic tank pumped by a licensed pumper within three years of the date of installation and at least once every three years thereafter, or when the sludge level reaches one-third of the liquid capacity of the tank. This program requires that your septic tank (and filter if applicable) be inspected and pumped if necessary and the drain field is functioning properly. This requirement is designed to protect and improve public health safety and groundwater quality. Proper Maintenance will prolong the life of the private sewage disposal system.
